**ORDER DENYING CERTAIN LATE CLAIM REQUESTS WITH PREJUDICE**

On May 15, 2006, the Court entered its Scheduling Order No. 2 Regarding Certain Late Claim Requests (the "Order"). The Order set a deadline of July 25, 2006 for the late claimants subject to the Order to file with the Court a response to Dow Corning's objection to their late claim requests (the "Objection"). Based on the Certifications of Non-Filing of Response (the "Certifications") that Dow Corning filed on August 11, 2006 and served on the same date on the late claimants identified on Appendix 1 attached hereto (the "Late Claimants"), the Court finds that copies of the Order and the Objection were mailed, postage prepaid, by Dow Corning to the Late Claimants on May 22, 2006 and June 20, 2006, respectively; that the service copies of the Order, the Objections, and the Certifications were not returned to Dow Corning as undeliverable; and that as of this date, the Late Claimants have not filed a response to the Objections or the Certifications.

Accordingly, it is ORDERED as follows:

1. The late claim requests filed by the Late Claimants listed on Appendix 1 hereto are hereby DENIED with prejudice.
2. This Order shall be entered in each of the Late Claimants' cases listed on Appendix 1 hereto. Upon entry of this Order in each case, such case shall be closed.
