**STIPULATED ORDER AUTHORIZING SEALING OF PLEADINGS
IN CERTAIN ADDITIONAL LATE CLAIMANT CASES**

On December 12, 2007, the Court entered an Agreed Order Allowing Certain Late Claimants Limited Rights to Participate in the Plan's Settlement Facility (the "Late Claim Order," dkt. no. 606). The Late Claim Order authorized the sealing of all pleadings and briefs on late claim matters ("CAC Pleadings") filed by the Claimants' Advisory Committee (the "CAC") in Master Docket Case No. 00-00005 and in the individual late claim cases of the Eligible Late Claimants. After the entry of the Late Claim Order, the CAC and Dow Corning Corporation ("DCC") identified additional cases, which have been closed (the "Closed Cases"), in which the CAC Pleadings were filed. The CAC and DCC agree that the CAC Pleadings in the Closed Cases should also be sealed. Accordingly, it is ORDERED that the CAC Pleadings filed in the Closed Cases identified on Appendix 1 hereto shall be withdrawn and sealed or removed from the public docket.
