**AMENDED AGREED ORDER MODIFYING  
CERTAIN FINAL DISEASE CURE DEADLINES**

On December 12, 2007 the Court entered the *Agreed Order Modifying Certain Final Disease Cure Deadlines* (Docket # 603) (hereinafter "Agreed Order") setting forth final disease cure deadlines for certain claimants who filed claims for certain eligible diseases or conditions. The parties have requested additional time to complete the dissemination of the guidelines regarding disease and disability criteria that are under the terms of the Agreed Order scheduled to be published on April 1, 2008 and certain dates thereafter. Therefore, it is **ORDERED** that the Agreed Order is amended as follows:

a) **General Connective Tissue Symptoms (GCTS)** – On or before May 1, 2008 the SF-DCT shall release information in the manner described in the Agreed Order concerning General Connective Tissue Symptoms (GCTS) claims. Claimants who received a Notification of Status letter from the SF-DCT stating that the SF-DCT reviewed their claim for GCTS and it was deficient AND whose cure deadline has or will run on or before November 2, 2008 (such claims are "Covered GCTS Claims" and such claimants are "Covered GCTS Claimants") must cure the deficiencies in their "Covered GCTS Claim" on or before November 3, 2008. This is the final cure deadline for Covered GCTS Claims. Covered GCTS Claimants who do not cure their deficiency on or by November 3, 2008 will have their claim denied pursuant to Section 7.09(b) of the Settlement Facility and Fund Distribution Agreement.

**b) Atypical Neurological Disease Syndrome (ANDS)** – On or before June 2, 2008 the SF-DCT shall release information in the manner described in the Agreed Order concerning Atypical Neurological Disease Syndrome (ANDS) claims. Claimants who received a Notification of Status letter from the SF-DCT stating that the SF-DCT reviewed their claim for ANDS and it was deficient AND whose cure deadline has or will run on or before November 30, 2008 (such claims are “Covered ANDS Claims” and such claimants are “Covered ANDS Claimants”) must cure the deficiencies in their Covered ANDS Claim on or before December 1, 2008. This is the final cure deadline for Covered ANDS Claims. Covered ANDS Claimants who do not cure their deficiency on or by December 1, 2008 will have their claim denied pursuant to Section 7.09(b) of the Settlement Facility and Fund Distribution Agreement.

**c) Systemic Lupus Erythematosus (SLE)** – On or before July 14, 2008 the SF-DCT shall release information in the manner described in the Agreed Order concerning Systemic Lupus Erythematosus (SLE) claims. Claimants who received a Notification of Status letter from the SF-DCT stating that the SF-DCT reviewed their claim for SLE and it was deficient AND whose cure deadline for SLE has or will run on or before January 13, 2008 (such claims are “Covered SLE Claims” and such claimants are “Covered SLE Claimants”) must cure the deficiencies in their Covered SLE Claim on or before January 14, 2009. This is the final cure deadline for Covered SLE Claims. Covered SLE Claimants who do not cure their deficiency on or by January 14, 2009 will have their SLE claim denied pursuant to Section 7.09(b) of the Settlement Facility and Fund Distribution Agreement.

**d) Atypical Connective Tissue Disease (ACTD)** – On or before September 2, 2008 the SF-DCT shall release information in the manner described in the Agreed Order concerning Atypical Connective Tissue Disease (ACTD) claims. Claimants who received a Notification of Status letter from the SF-DCT stating that the SF-DCT reviewed their claim for ACTD and it was

deficient AND whose cure deadline has or will run on or before March 1, 2009 (such claims are "Covered ACTD Claims" and such claimants are "Covered ACTD Claimants") must cure the deficiencies in their Covered ACTD Claim on or before March 2, 2009. This is the final cure deadline for Covered ACTD Claims. Covered ACTD Claimants who do not cure their deficiency on or by March 2, 2009 will have their claim denied pursuant to Section 7.09(b) of the Settlement Facility and Fund Distribution Agreement.

This Amended Order is intended only to change the dates for the dissemination of the disease and disability information described above and the specific cure deadlines for the claims defined above as Covered GCTS Claims, Covered ANDS Claims, Covered SLE Claims and Covered ACTD Claims. All other provisions in the Agreed Order of December 12, 2007 remain in effect. Neither this Amended Order nor the Agreed Order amends or is intended to amend any provisions of the Amended Joint Plan of Reorganization.
