STIPULATION AND ORDER REGARDING DISPOSITION OF
CERTAIN DOCUMENTS AND MATERIALS MAINTAINED IN THE
DOW SILICONES CORPORATION LITIGATION DOCUMENT CENTER

Whereas the Claimants’ Advisory Committee (CAC), Dow Silicones Corporation (DSC), and the Debtor’s Representatives (DRs) (collectively, the “Parties”) agree as follows:

1. The final deadline for submitting claims to the Settlement Facility-Dow Corning Trust (SF-DCT) is June 3, 2019.
2. The SF-DCT operations and facilities will terminate at some point after this final deadline and once all claims have been processed and Allowed claims have been paid.
3. In light of the impending conclusion of settlement operations, the Parties have agreed to the disposition of certain documents and materials currently maintained in the Dow Litigation Document Center (LDC) as set forth herein.
 - a. **Destruction of Expert Transcripts and Related Documents.** Effective upon entry of this Order, DSC shall be authorized to destroy all “expert” documents, including deposition transcripts and any other materials related to expert reports developed in the course of the implant litigation against Dow Corning.
 - b. **Destruction/Disposition of Medical Materials and Devices.** Effective June 4, 2019, DSC shall be authorized to destroy all medical materials and devices stored in the LDC.
 - c. **Destruction of Medical Records.** Effective December 31, 2019, DSC shall be authorized to destroy all medical records stored in the LDC.

- d. **Other Litigation and Legal Documents Unrelated to Individuals or Settling Claimants.** Effective as of January 1, 2019, DSC shall be authorized to destroy all other files and documents maintained in the LDC that are not defined in the categories above and that do not relate to an individual or a claimant.
