**STIPULATION AND ORDER OF DISMISSAL REGARDING
DOCKET #41 AND DOCKET #50 REGARDING TOLLING
OF THE 24-MONTH, 5 YEAR DISEASE OPTION II CRITERIA**

Whereas the Claimants' Advisory Committee ("CAC"), Dow Silicones Corporation ("DSC") and the Debtor's Representatives ("DRs") agree as follows:

1. The CAC filed *Motion of Claimants' Advisory Committee To Interpret Annex A, The Claims Resolution Procedures, Schedule II, Part B, General Criteria (A) – Tolling* (filed on July 19, 2004, Docket #41) ("CAC Motion").

2. Dow Corning Corporation, now DSC, filed *Motion by Dow Corning For A Determination That The Tolling Provision In The Disease Option II Guidelines Does Not Modify The "24-Month" Eligibility Requirement* (filed on July 19, 2004, Docket #50) ("DSC Motion").

3. The Plan Interpretation issue raised in the CAC Motion and the DSC Motion is no longer in dispute. Therefore, the CAC, DSC, and DRs stipulate and agree to dismiss both motions with prejudice pursuant to Fed.R.Civ.P. 41(a)(1)(A)(ii), dismissal of action signed by all parties who have appeared.

Accordingly, this Court ORDERS and DIRECTS as follows:

The CAC motion Docket #41 and the DSC Motion Docket #50 are hereby dismissed with prejudice.
