**NOTICE OF POSTING OF LIST OF SID NUMBERS (CLAIMANT
IDENTIFICATION NUMBERS) OF CLAIMANTS WHOSE ADDRESS
CANNOT BE VERIFIED AND WHO HAVE 90 DAYS (UNTIL APRIL 12, 2023)
TO PROVIDE A CURRENT VERIFIED ADDRESS OR THE CLAIM SHALL BE
PERMANATELY CLOSED**

On June 13, 2022, the Court entered Closing Order 5 – Notice that Certain Claims Without a Confirmed Current Address Shall be Closed and Establishing Protocols for Addressing Payments for Claimants In Bankruptcy, ECF No. 1642 (“Closing Order 5”). Closing Order 5 stated:

The Settlement Facility shall post on its website a list of the SID numbers (claimant identification numbers) for those claimants who have been identified as having a “bad address” and those who have not responded to the verification mailing on or before the date that is four weeks after the mailing to those claimants. The Settlement Facility shall maintain this list on its website for 90 days. If a claimant responds on or before the end of that 90-day period, the SID number shall be removed from the posted list and the Settlement Facility will proceed to finalize processing or payment of the claim as appropriate. If the claimant does not respond on or before the end of the 90-day period, the claim shall be permanently closed.

Closing Order 5, ECF No. 1642, PageID.28803-04.

The Settlement Facility posted an initial list of SID numbers pursuant to Closing Order 5 on June 19, 2022 and the 90-day deadline to respond to that posting and notify the Settlement Facility of their contact information expired on September 17, 2022. Pursuant to Closing Order 5, the claims of those who did not timely respond were permanently closed.

This notice is to inform claimants that the Settlement Facility has identified approximately 1,187 additional claimants who have not verified their address with the Settlement Facility and is posting a second list of SID numbers on its website (<https://www.sfdct.com>) on this date (January 12, 2023) pursuant to Closing Order 5. Pursuant to Closing Order 5, the Settlement Facility shall maintain this list on its website for 90 days – until April 12, 2023. If a claimant responds on or before the end of that 90-day period, the SID number shall be removed from the posted list and the Settlement Facility will proceed to finalize processing or payment of the claim as appropriate. **If the claimant does not respond on or before April 12, 2023, that claim shall be permanently closed.**
