**NOTICE OF TIMELINE FOR MAILING OF MATERIALS REQUIRED
BY THE ORDER TO SHOW CAUSE (ECF No. 1699)**

The Finance Committee hereby seeks to notify the Court that of the timeline for printing and mailing the materials required by the Court's March 28, 2023 Order to Show Cause (ECF No. 1699). This notification is relevant because the CAC's Motion to Reconsider and Vacate Order to Show Cause and Response to the Finance Committee's Motion for Order to Show Cause (ECF No. 1703) is currently pending before the court, and the Court's ruling on that motion may impact the deadlines established by the Order to Show Cause as well as the timing of the mailing to the affected attorneys and law firms. In order for the SF-DCT to mail out the Order to Show Cause and the Audit Survey form to each law firm and attorney listed on Sealed Exhibit 1A in time for those firms to file a written response with the Court by May 5, 2023 as required by the Order to Show Cause, the SF-DCT must begin the printing and mailing process on Wednesday, April 5, 2023. However, if the Order to Show Cause is to be vacated, or the show cause proceedings are to be adjourned to permit consideration of the CAC's motion and response, the SF-DCT will halt the printing and mailing process and avoid waste of the costs and resources associated with the mailing to 814 attorneys/firms.
