AGREED ORDER ALLOWING SUBSTANTIAL CONTRIBUTION CLAIM FILED BY SYBIL NIDEN GOLDRICH

On January 3 and June 16, 2005, Sybil Niden Goldrich filed, respectively, an application and an amended application (together, the "Claim") for the allowance of a substantial contribution claim pursuant to 11 U.S.C. § 503(b) and section 9.02 of Annex A to the Settlement Facility and Fund Distribution Agreement. Reorganized Dow Corning and the Debtor's Representatives (together, "Dow Corning") filed objections to the Claim, and the Claimants' Advisory Committee (the "CAC") filed pleadings in support of the Claim. Following an extensive analysis of the Claim and other relevant materials, Dow Corning, the CAC, Mrs. Goldrich and her attorneys engaged in mediation in an effort to resolve the Claim. Such parties have reached an agreement to partially allow the Claim, on the terms set forth below. Based on the parties' agreement, as evidenced by their signatures below, it is hereby ORDERED as follows:

- Mrs. Goldrich's Claim is hereby allowed in the total amount of \$197,500.00. All 1. other amounts requested in the Claim are hereby denied.
- 2. Mrs. Goldrich may request that the Finance Committee promptly direct the Settlement Facility to pay the Claim in the amount specified in this Agreed Order from the Settlement Fund (as defined in the Settlement Facility and Fund Distribution Agreement).
