**AGREED ORDER ALLOWING SUBSTANTIAL CONTRIBUTION  
CLAIM FILED BY DOFFERMYRE, SHIELDS, CANFIELD,  
KNOWLES & DEVINE AND JACKS LAW FIRM**


The law firm of Doffermyre, Shields, Canfield, Knowles & Devine (“DSCKD”) and Tommy Jacks, formerly of the law firm of Mithoff & Jacks, LLP, and now of the Jacks Law Firm (“Jacks”) filed claims for the allowance of substantial contribution claims pursuant to 11 U.S.C. § 503(b)(4) and Section 9.02 of Annex A to the Settlement Facility and Fund Distribution Agreement (“the Claim”). Objections to the Claim were filed by the Reorganized Debtor and Debtor’s Representatives and the Claimants’ Advisory Committee (“CAC”). Following an extensive analysis of the Claim, the supporting time documentation submitted therewith, the Declaration of Tommy Jacks, and relevant authorities, the Debtor’s Representatives, the CAC and other parties in interest engaged in settlement discussions, including a mediation, with DSCKD and Jacks in an effort to resolve the objections to the Claim. Such parties have reached an agreement to resolve these objections and partially allow the Claim on the terms set forth below.<sup>1</sup> Based on

the parties' agreement, as evidenced by their signatures below, it is hereby ORDERED as follows:


1. DSCKD's claim is hereby allowed in the total amount of \$2,435,800.00.
2. Jacks's claim is hereby allowed in the total amount of \$1,500,000.00.
3. All other amounts requested in the Claim by DSCKD and Jacks are hereby denied.
4. The Finance Committee shall direct the Settlement Facility to pay the Claim in the amounts specified in this Agreed Order from the Settlement Fund (as defined in the Settlement Facility and Fund Distribution Agreement) by wire transfer of such amounts to the accounts designated by DSCKD and Jacks, such transfer to be completed within five (5) business days after the date of this Agreed Order.


