**AGREED ORDER EXTENDING CERTAIN DEADLINES IN SCHEDULING  
ORDER NO. 3 FOR CERTAIN DISPUTED LATE CLAIM REQUESTS (GROUP 2)**

On February 9, 2007, the Court issued Scheduling Order No. 3 for Certain Disputed Late Claim Requests (Group 2) (the "Scheduling Order"). Upon the agreement of the Claimants' Advisory Committee ("CAC") and Dow Corning Corporation ("DCC") to extend the deadlines and hearing dates in the Scheduling Order, it is hereby ORDERED as follows:

1. The deadline in paragraphs 4 and 5 of the Scheduling Order for DCC and the CAC to submit and serve their witness lists, exhibit lists, and exhibits is extended from April 27, 2007 to **July 6, 2007**.

2. The deadline in paragraphs 6 and 7 of the Scheduling Order for Late Claimants, DCC, and the CAC to submit additional witnesses and exhibits is extended from May 25, 2007 to **August 3, 2007**.

3. The deadline in paragraph 8 of the Scheduling Order for the completion of discovery is extended from July 20, 2007 to **September 28, 2007**.

4. The final hearing date in paragraph 9(a) of the Scheduling Order for the following Late Claimants is extended from October 4, 2007 to **December 13, 2007 at 10:00 A.M.** Eastern
