Dear Ms. Pendleton:

We have had an opportunity to review the matters in question with Dow.

passed away 3-3-2013. She left a Last Will & Testament with heir indications. Those heirs are listed as being: her son and daughter. We are unaware of whether the Last Will & Testament was probated in Oklahoma. Our accounting indicates settlement portions were distributed to the heirs.

passed away 12-7-2007; we do not have any record indicating there is a Last Will & Testament. Her daughter, is listed as her next of kin on the death certificate. Our accounting does not indicate payment has been distributed to the daughter, so those settlement funds continue to be held in our Trust Account.

passed away 2-28-2010. We made attempts to contact the heirs listed in her Estate and those heirs could not arrive at an agreement with regard to the distribution of funds from DOW. Our accounting indicates these funds remain in our Trust Account.

has not passed away; our accounting indicates her settlement funds were sent and distributed directly to Janice Sessions.

Our records do not indicate that she has passed away. We have made attempts to locate both and any potential heirs to her Estate. Our accounting indicates the Settlement Funds from Dow remain in our trust account.

Please advise what you would have us do from here.
