Dear Mr. Kirtner,

Ernie Hornsby and I are writing as members of the Claimants' Advisory Committee in the Dow Corning bankruptcy settlement regarding your breast implant client in the Settlement Facility - Dow Corning Trust (SF-DCT). Your client's name is _____ (SID 0951227). (See attached document) We are sending this email to you because questions have arisen about two payments to _____ and the Settlement Facility has asked us to assist them. The Settlement Facility sent a Rupture Premium Payment of \$2,500 to you on 10/14/2014 and a Disease Premium Payment of \$2,000 on 10/14/2014. The Settlement Facility sent a copy of the award letters to _____ however, the letters were returned as undeliverable, suggesting that the claimant had moved. Ellen Bearicks of the SF-DCT informs us that she has requested that you provide her with the updated address for _____ but you have not done so. We are writing because under the Settlement Plan, Article X, "all funds in the Settlement Facility are in the custody of the Court until the funds have actually been paid to and received by the Claimant (or a legally authorized recipient.)" This means that if you received the claimant payments and deposited them into your law firm's IOLTA / trust account but the payments were not distributed to the claimant or her heirs within 180 days, then the entire claimant payment must be returned to the SF-DCT. The funds cannot remain in your law firm's trust account indefinitely. Please provide documentation to the Settlement Facility with the updated address for _____ and affirmation that the funds were distributed to her. The Finance Committee is about to seek an

Order to Show Cause against you and your law firm to have the funds returned to them unless an updated address for _____ is provided to them immediately. We asked them to temporarily defer doing this so that we could have an opportunity to intervene and see if this matter could be resolved.

Please respond to acknowledge receipt of this email and/or contact Ellen Bearicks directly so that this matter can be resolved before an Order to Show Cause is filed.
