## ORDER No. 34 (Show Cause Why Listed Cases Should Not Be Remanded to State Court)

Pending before the court are motions by plaintiffs in the cases listed in the appendix to this Order seeking remand to state courts of their claims against defendants other than Dow Corning Corp., accompanied by requests either to dismiss or to sever any claims against Dow Corning Corp. Upon consideration, it is ORDERED as follows:

- 1. All affected parties are directed to show cause in writing to this court by September 24, 1996, why the listed cases should not be remanded to the state courts shown in the appendix subject to the terms and conditions of this order.
  - 2. The terms and conditions under which such remands would be effected are as follows:
  - (a) Any claims by plaintiffs against Dow Corning Corp. (and any crossclaims or third-party claims by defendants against Dow Corning Corp.) would be severed and not remanded. Such claims would, however, be administratively closed in this court and dismissed without prejudice to the institution and pursuit of such claims in the United States District and Bankruptcy Courts for the Eastern District of Michigan in accordance with procedures established in those courts. This court would retain jurisdiction to vacate such dismissals and reopen such claims against Dow Corning on written motion if filed within 30 days after reorganization proceeding of Dow Corning are dismissed or within 30 days after the Eastern District of Michigan determines that reopening of such cases against Dow Corning is the procedure to be followed in pursuing such claims.
  - (b) Any claims by plaintiffs against the "Bioplasty defendants" would be dismissed with prejudice (but without prejudice to any rights of such plaintiffs to participate in the distribution of the Bioplasty settlement fund in accordance with such plan as may ultimately be approved by this court).
  - (c) Any claims by plaintiffs against the "Mentor defendants" relating to breast implants implanted before June 1, 1993, would be dismissed with prejudice (but without prejudice to the rights of any such plaintiffs to participate in the distribution of the Mentor settlement fund in accordance with such plan as may ultimately be approved by this court).
- (d) Any claims by plaintiffs against Bristol-Myers Squibb Co., Medical Engineering Corp. Baxter Healthcare Corp., Baxter International Inc., Minnesota Mining and Manufacturing Co. ("3M"), Union Carbide Corporation, Inamed Corp., and McGhan Medical Corp. would be remanded, but could be pursued in state court only upon demonstration that the plaintiffs, if eligible, timely opted out of the

original Global Settlement or the Revised Settlement Program provided by those defendants. Counsel are cautioned that at this time these defendants are subject to certain restrictions imposed under paragraph 3 of Order No. 27 with respect to the timing and nature of settlement discussions.

- (e) Any claims by plaintiffs against Corning, Incorporated, the "Scotfoam defendants," Surgitek, Inc., and Cabot Medical Corp. would, in view of final summary judgments having been entered in favor of such defendants through earlier orders in MDL 926 and Master File No. CV 92-P-10000-S, be dismissed with prejudice.
- (f) Any claims by plaintiffs against The Dow Chemical Company and Dow Holdings would be remanded, as would claims against other defendants not described in paragraphs 1(a) through 1(e).
- (g) Further proceedings in state courts would be governed, in general and to the extent applicable, by the orders previously entered in MDL 926 and Master File No. CV 92-P-10000-S. To the extent not inconsistent with state law, the provisions of Order No. 30 would apply to such further proceedings, except that paragraph 8 of that Order and Order No. 13, imposing an assessment on recoveries for "common benefit" services and expenses, would not apply to recoveries by plaintiffs who exercised their initial right to opt out of the *Lindsey* class and whose state-court case was removed to federal court under the "related to bankruptcy" jurisdiction.
- (h) If the Sixth Circuit Court of Appeals, in the appeals before it from Judge Hood's order of July 30, 1996, holds that the Eastern District of Michigan should exercise "related to bankruptcy" jurisdiction over claims against The Dow Chemical Company (or any other defendant), then any claims remanded to state court against such defendant(s) would be subject to dismissal without prejudice. This court would retain jurisdiction, in such event, to reopen the case against such defendant(s) upon written motion filed within 30 days after the effective date of the mandate of such appellate court.
- 3. This "show cause" order will be filed only in Master File CV 92-P-10000-S. After expiration of the time for indicating objections, a new order will be prepared for docketing and filing in those cases that are directed to be remanded.
