**ORDER No. 51  
(Setting status/scheduling conferences--ALN cases)**

The cases listed in the appendix to this order are set for status/scheduling conferences in Birmingham at the dates and times indicated.

The cases in this appendix are ones that have NOT been denominated as "EFILE cases" but were originally filed in the Northern District of Alabama, or were removed from Alabama state courts to the Northern District of Alabama, or were transferred by other federal courts to the Northern District of Alabama under 28 U.S.C. § 1404 (rather than through the Judicial Panel on Multidistrict Litigation under § 1407). (The EFILE cases are being set for status/scheduling conference during this same time period by Order 51A, which is being filed through the EFILE procedures in CV98-10000.)

Counsel wishing to participate in these conferences by telephone are responsible for making the necessary arrangements. Counsel are also requested to make know to other counsel of record (particularly those who have not be "active" in breast implant cases) the setting of these cases.

Unless this has already been done, counsel for plaintiffs should file and serve on opposing counsel a statement (using appendices if the attorney has a substantial number of cases) indicating the remaining plaintiffs, the defendants against whom the plaintiff proposes to proceed, and "opt-out" information if claims are to be pursued against the settling defendants under the Revised Settlement Program. Plaintiffs' counsel should also consider whether the case might be dismissed or administratively closed on the same terms as provided in Order 44B and, where a case has been settled, submit an appropriate order to the court for signature.
