**ORDER No. 52D
(Closing of Cases)**

On November 12, 1999, this court entered Order No. 52C, a copy of which was mailed to the last known address of each plaintiff (or that person's listed attorneys) as well as being posted on the court's webpage. The order directed that a written response be filed with the Clerk of this court by December 15, 1999, if there was a request that the case (or the claim of a particular plaintiff) not be closed, each party bearing its own costs, though preserving rights to pursue claims against Dow Corning as may be authorized by the Bankruptcy Court of the Eastern District of Michigan, preserving the rights of the plaintiff(s) to pursue claims against The Dow Chemical Company in the District Court of the Eastern District of Michigan to the extent permitted by the District and Bankruptcy Courts of that district, and without prejudice to the rights, if any, of the plaintiff(s) as participants in the Revised Settlement Plan, the Foreign Settlement Plan, and Inamed/McGhan/CUI settlement plan. The order specified that, absent such a response, those cases/claims would be so closed.

With respect to the cases listed in the appendix to this order the court has either received a response indicating that such an order would be appropriate or has not received any response indicating that such an order would be inappropriate and, accordingly, it is hereby ORDERED that the cases listed in the appendix to this order are hereby closed, each party bearing its own costs, preserving, however, the rights of the plaintiff(s) to pursue claims against Dow Corning as may be authorized by the Bankruptcy Court of the Eastern District of Michigan, preserving the rights of the plaintiff(s) to pursue claims against The Dow Chemical Company in the District Court of the Eastern District of Michigan to the extent permitted by the District and Bankruptcy Courts of that district, and without prejudice to the rights, if any, of the plaintiff(s) as participants in the Revised Settlement Plan, the Foreign Settlement Plan, and Inamed/McGhan/CUI settlement plan.

A copy of this order shall be docketed and filed in each of the cases listed in the appendix. Inasmuch as these closings constitute final orders, counsel are cautioned as to the time limits under F.R.Civ.P. 59 and 60 for filing post-judgment motions to modify or vacate final orders.
