

FACILITY AND REQUEST FOR EXPEDITED CONSIDERATION**


The Motion of Claimants' Advisory Committee For The Disclosure Of Substantive Criteria Created By, Adopted And/Or Being Applied By The Settlement Facility and Request For Expedited Consideration was filed on December 7, 2004. On January 6, 2005, a *Motion And Brief Adopting The Motion of the Claimants' Advisory Committee For the Disclosure of Substantive Criteria Created, Adopted And/Or Being Applied By The Settlement Facility And Request For Expedited Consideration* was filed by counsel representing various Disability A Claimants. The Debtor's Representatives filed a Joint Response to both motions on January 21, 2005. The reply brief is due on January 28, 2005. To further facilitate discussion among the parties in narrowing the issues and reach agreement on specific issues, the Claimants' Advisory Committee has requested an additional six business days to file its reply, or until Monday, February 7, 2005. Counsel representing the various Disability A Claimants has also requested a similar extension of time to file a reply. The Debtor's Representatives have agreed to the extensions for both motions.


The Court hereby ORDERS that the extension is granted and the response date for the various Disability A Claimants will be February 7, 2005.
