# STIPULATION TO APPOINT DAVID AUSTERN AS SUCCESSOR CLAIMS ADMINISTRATOR FOR THE SETTLEMENT FACILITY-DOW CORNING TRUST

### **Background**

The Amended Joint Plan of Reorganization (the "Plan") establishes that a Claims Administrator shall be responsible to oversee the processing and payment of claims by the Settlement Facility Dow Corning Trust (the "SF-DCT") in accordance with the terms of the Settlement Facility and Fund Distribution Agreement (the "Settlement Facility Agreement" or "SFA"). Plan at § 1.29.

In general, the Claims Administrator is responsible for:

(i) supervising processing of claims resolved under the terms of this Settlement Facility Agreement and the Claims Resolution Procedures and overseeing all aspects of the Claims Office including the Quality Control Supervisor and the Operations Manager, (ii) preparing and distributing periodic reports documenting the activity of the Claims Office, including detailed reports on Claims submissions and resolutions, and (iii) serving as a member of the Finance Committee and specifically performing periodic analyses and estimates regarding the costs and projected costs of processing and resolving claims subject to the terms of this Agreement and any matter of contingency that could affect the sufficiency of funds for payment of allowed claims. The Claims Administrator shall seek the input and advice of the Claimants' Advisory Committee and the Debtor's Representatives on all matters of mutual concern

and as specified at Section 5.05.

SFA at § 4.02(a). See also SFA at § 4.02 (e) ("General Powers of the Claims Administrator").

After serving as the Claims Administrator for more than four years, Elizabeth
Wendy Trachte-Huber concludes her tenure on April 22, 2005. The Settlement Facility
Agreement gives the Claimants' Advisory Committee ("CAC") and the Debtor's
Representatives the responsibility and authority jointly to select a successor Claims
Administrator subject to the approval of this Court:

In the event that the Claims Administrator resigns or is removed from office or is otherwise unable to perform the functions of the Claims Administrator, a successor Claims Administrator shall be selected by the Debtor's Representatives and the Claimants' Advisory Committee, subject to the approval of the District Court.

Settlement Facility Agreement at § 4.02(b). The Debtor's Representatives and the CAC have selected David Austern to be the successor Claims Administrator and have submitted this Stipulation to approve the selection of David Austern as successor Claims Administrator.

#### **Qualifications of Claims Administrator**

The Settlement Facility Agreement sets forth the requirements for the qualifications of the Claims Administrator. He or she is to be "(i) an individual over the age of 35 whose experience and background are appropriate for the responsibilities

hereunder, and (ii) at the time of the appointment and at all times during the terms of service, independent." SFA at § 4.02(c).

As set forth below and in the accompanying affidavit of David Austern attached hereto as Exhibit A (the "Austern Aff."), Mr. Austern satisfies these criteria and is well-qualified to serve as the successor Claims Administrator.

Mr. Austern 's experience and background make him particularly qualified for the responsibilities he would assume as Claims Administrator of the SF-DCT. Few, if any, individuals have such extensive experience in running claims facilities. Mr. Austern's expertise and experience are well recognized. Mr. Austern has served as General Counsel for the Manville Personal Injury Settlement Trust (the "Manville Trust") since 1987. Id. at Ex. 1. Additionally, since May 2000 he has been President of the Claims Resolution Management Corporation ("CRMC"), which processes asbestos personal injury claims, contribution claims, and indemnity claims for the Manville Trust and the Pacor Trust. Id. Prior to that time, Mr. Austern had also been an Assistant United States Attorney in Washington, D.C., an Assistant District Attorney in New York, and an attorney in private practice. He has also taught as an Adjunct Professor and Lecturer at several law schools, and is a graduate of the University of Pennsylvania and of Yale Law School. Id.

Mr. Austern is also uniquely qualified because of his existing experience with the SF-DCT. In January and February 2005, he conducted a thorough management review of the SF-DCT, which is currently in the process of implementing various recommendations that he made. As a result of this experience, Mr. Austern is already familiar with (i) the Plan, the Settlement Facility Agreement and other implementing documents, (ii) the claims staff, and (iii) the issues that have arisen during the implementation.

The CAC and the Debtor's Representatives thus agree that Mr. Austern's appointment will protect the SF-DCT from a prolonged transition period since his experience will allow him to assume the position of Claims Administrator without significant additional preparation and since his prompt appointment will avoid a lengthy search process.

Mr. Austern's appointment will therefore allow the SF-DCT to move forward without interruption so that the main task of reviewing and paying qualified claims can proceed expeditiously.

Mr. Austern is also "independent" as required by the Settlement Facility Agreement. SFA at § 4.02(c). As set forth in his accompanying affidavit, none of the situations set forth in the Settlement Facility Agreement which would preclude a candidate from being found "independent" applies to Mr. Austern.

The compensation to be paid to Mr. Austern as Claims Administrator is set forth in a proposed contract for consulting services. The fees cover services to be provided by Mr. Austern and a minimum of two additional individuals from the CRMC whom Mr. Austern will select to assist in various tasks. Pursuant to the proposed contract, payment will be made directly to the CRMC or to Mr. Austern directly for deposit to the CRMC. Mr. Austern will not personally receive compensation by the SF-DCT. The parties expect that Mr. Austern's fees, including expenses, will be comparable to or less than total costs currently being paid.

Day-to-day operations and directives will continue to be carried out under the supervision of the Claims Administrator by the Claims Operations Manager and other senior management staff of the SF-DCT. As Claims Administrator, Mr. Austern will establish the directives and provide guidance and instruction to the Claims Operations Manager and staff. Under the terms of the agreement Mr. Austern will devote as much time as necessary to assure that the Settlement Facility is functioning properly. Under the terms of the contract for consulting services, Mr. Austern's appointment as Claims Administrator will extend for a one-year period, subject to renewal. The contract provides for termination by either party before the end of the one-year period.

The audit process at the SF-DCT that has been commenced by Analysis Research Planning Consulting ("ARPC") will continue.

The Debtor's Representatives and the CAC have therefore submitted this Stipulation to the Court to approve the selection of David Austern as successor Claims Administrator effective May 23, 2005.

# ORDER APPROVING STIPULATION APPOINTING DAVID AUSTERN AS SUCCESSOR CLAIMS ADMINISTRATOR FOR THE SETTLEMENT FACILITY-DOW CORNING TRUST

After consideration of the agreement of the Debtor's Representatives and the CAC, it is hereby ORDERED that:

- David Austern's selection as successor Claims Administrator effective May 23,
   2005 is hereby approved.
- 2. The Finance Committee is directed to authorize the Settlement Facility-Dow Corning Trustee to execute the approved Consulting Agreement with David Austern and to perform their respective obligations thereunder.
- 3. All actions taken at any time by David Austern as the Claims Administrator (or by any employees, agents, or independent contractors engaged by Mr. Austern as the Claims Administrator or appointed or hired to perform services in assisting the Claims Administrator) in implementing the Settlement Facility and in collecting, collating, processing, evaluating, and paying claims shall be performed in accordance with the terms of the Plan and the Plan Documents (as defined in the Plan); and

4. The actions taken by David Austern described in the preceding paragraph 3 shall constitute judicial actions of this Court and shall be protected, to the maximum extent allowable by law, by the doctrine of judicial immunity. The relief granted in this paragraph shall be effective from this date until the Claims Administrator resigns, is terminated or the Consulting Agreement expires and is not renewed.
