**ORDER VACATING ORDER DENYING LATE CLAIM REQUEST**

On September 28, 2006, the Court entered an Order Denying Late Claim Request of Sandra Ray (the "Order") in this case based on Sandra Ray's failure to file a Response to Dow Corning's objection to her claim by the July 25, 2006 deadline set in the Court's Scheduling Order No. 2 Regarding Certain Late Claim Requests (the "Scheduling Order"), which was entered on May 15, 2006. After the entry of the Order, Ms. Edwards contacted the Claimants Advisory Committee ("CAC") and advised that due to problems with her attorney (who no longer represents her), she did not receive the Scheduling Order or the objection and thus had no knowledge of the July 25 deadline for filing her Response. Dow Corning and the CAC have agreed to Ms. Ray's request to vacate the Order on the terms set forth below.

Accordingly, it is ORDERED as follows:

1. The above-captioned case shall be reopened and the Order Denying Late Claim Request of Sandra Ray entered herein on September 28, 2006 is hereby vacated.
2. Sandra Ray shall be subject to the Third Notice of Disputed Late Claim Requests and Proposed Scheduling Orders, which Dow Corning filed on September 29, 2006, and to any scheduling orders the Court may subsequently issue pursuant to such Third Notice that pertain to Ms. Ray's late claim request.
